A special membership meeting to receive nominations for all positions will be held on May 2, 2022, at 5:00 P.M. at the Local 25 Offices, 901 K St., N.W. Suite 200, Washington, DC.

All candidates for any office or position must accept the nomination prior to the close of nominations, and do so either in person, or in a writing submitted to the Local 25 Election Committee.

To be eligible to run for any of the above-listed offices or positions, a member of Local 25 must meet both of the following requirements:

1. Continuous active good standing for at least 6 months immediately preceding nominations; and
2. Actively attached to the trade for at least one year. Active attachment shall be deemed to include and not be interrupted by temporary unemployment due to illness, economic conditions, or other good cause; or service as a full-time paid officer or employee of UNITE HERE or any of its affiliates.

No candidate may be nominated for more than one office. The candidate names will be listed on the ballot in the order of nominations. Slate nomination and voting will be allowed and will be listed together on the ballot.

SPECIAL NOTICE FOR MEMBERS EMPLOYED IN WILLIAMSBURG ONLY:
By resolution of the Executive Board, members employed in Williamsburg who seek nomination to any office may submit a written request to the Chairperson of the Election Committee, asking that the Chairperson serve as the nominator and that the Chairperson appoint another member of the Election Committee to serve as a second for the nomination. Any such requests must be sent to the Chairperson c/o the Union's Washington, D.C. office, and must be received no later than one hour prior to the official starting time of the nominations meeting. It is the sole responsibility of the member seeking nomination to ensure that his or her request is received in a timely fashion.
